Many a reader believe that the characters and their portrayal have a tremendous impact on the significant parts of the play. The elements which are supernatural are noticed by the audience in a majority of Shakespearean dramas particularly in two of the tragedies namely Hamlet and Macbeth. Similarly the way love has

The play Merchant of Venice is so near to human beings that a friend risks his own life in order to help another friend. Bassanio wanted to woo and marry the fair Princess Portia of Belmont. Antonio had to furnish Bassanio with the required money to go to Belmont. All the money of Antonio was in the form of goods and merchandise sent in ships to different parts of Europe. Hence Antonio was forced to raise a loan. Shylock gave them the required loan of 3000 ducats for 3 months. A bond was extracted from Antonio that if the loan was not returned before the stipulated date, Shylock is entitled to cut a pound of flesh from any part of Antonio's body. The reason why Shylock made Antonio sign such a bond is that Antonio used to lend money to many venetians in times of need without charging any interest. That spoiled the business of Shylock who was a usurer. He charged exorbitant rates of Interest. He was insulted by Antonio many times before in the market place and called a dog. Shylock was looking for an opportune moment to carry out his revenge. Here the readers are confused with a question whether Shylock was more sinned against than sinning. As expected by Shylock the money taken as loan was not repaid on time and Shylock took the matter to the court. All the wise men including the Duke requested him to show pity on a Christian. Shylock did not budge and wanted to go ahead with what was mentioned in the bond, which entitled him to cut a pound of flesh. Shylock was now reminded of the harsh treatment meted out to him in a Christian land. He was a Jewish money lender and all the Jews were forced to wear a red cap in Venice. He was spat on the face by Antonio some time ago, he was called a dog and was further infuriated with different kinds of insults. So,Shylock did not want to let this opportunity of taking revenge on Antonio slip away. The question is why was Shylock illtreated by the Venetians and was it wrong to be a money lender? The reason is clear. Lending money to the needy is not wrong but expecting them to pay interest on the loan raised is considered a sin in the Christian land. Ultimately Shylock lost the case when Portia dressed as a male lawyer won the case in favour of Antonio. She informed that Shylock is entitled only to a pound of flesh and not a single drop of Christian blood should fall on the ground. Shylock then got ready to receive twice the amount of money which was offered to him but he had unmindfully refused to accept earlier

because he was blinded by his revengeful attitude. But he is justified in his actions as Jews were illtreated in Venice. Shylock was not allowed to receive the money which was twice the amount taken as loan. In fact he had to pay a fine to the Government for plotting to kill a Christian and he was really devastated when he was asked to convert himself into a Christian. This sort of play 'The Merchant of Venice' is all the more convincing both to the reader and the audience as to how friendship can do a lot in spite of the risks involved in going out of the way to help a friend in need. Surprisingly Antonio remained a bachelor throughout his life but helped by risking his life after signing the deadly bond just to furnish Bassanio with the money required to travel to Belmont and marry the fair Princess Portia. The paly appeals to the reader in all possible ways. Firstly, the strength of friendship is well understood but at the same time many of the audience and the readers take the sides of Shylock and pity him profusely. There is another reason why he hated Christians. His daughter eloped with a Christian and married Lorenzo. The caskets scene is a ploy employed by Shakespeare to weave a kind of suspense in the play. The themes like revenge, love, friendship, money lending, profit motive, elopement etc are common scenarios in real life situations. Hence when these are touched and dwelt upon by a seasoned playwright like William Shakespeare in almost all his plays, they will never elude recognition and popularity. That is the reason why Shakespeare stays relevant even to this day in every nook and corner of the world. The promising nature of the plays will never bore the audience anytime. They are almost like epics which stand the test of time.
There is no surprize why William Shakespeare's plays are still read and themes exist to this day in the present century. In literature, movies and the stage The Shakespearean themes are preserved and appreciated by the world at large.
